TEACHING CONTENT (SUBJECT DESCRIPTION)			

TEACHING CONTENT (SUBJECT DESCRIPTION)

This course addresses contemporary issues and arguments in moral, socialand political philosophy. It will provide some historical introduction and an account of certain key concepts, such as public versus private and individual versus common goods. It will then engage a number of areas of social life and action (such as, for instance, culture, art, economics, law, education,family) examining contested values and policies. The broad orientation is towards "practical philosophy"
