IV. Opis przedmiotu/ treści programowe

The course is addressed to the students interested in the European Union's Foreign Policy. During the course students broaden their knowledge in the field of the EU's foreign policy towards the eastern neighbours after two biggest enlargements of the European Union in 2004 and 2007, includes Ukraine, Belarus, Moldova, the Southern Caucasus states and Russia. Students identify the aims, the nature, specificity and the genesis of the EU's Eastern Policy and CFSP as well. Students will analyse the concepts of the European Neighbourhood Policy of the EU and the institutions, instruments and structures of the Eastern Policy. The main part of this subject is the empirical side of the EU's Eastern Policy – the bilateral EU - eastern neighbours relations, mainly political, economical and social dialogue. It is concerned also the future of the EU's Eastern Policy and political development in the region.

Topics covered by the course:

1. External relations of the EU (Common Foreign and Security Policy of the EU)
2. Eastern Policy of the European Union (genesis and forms, Eastern Europe countries)
3. Eastern policy of Poland and the other EU countries
