# Treści programowe przedmiotu:

The topics covered in this course will include:1. Family psychology in Poland, main areas of interest and their changes2. Systems theory as a framework for family studies, the basic concepts of General Systems Theory 3. Definition of a family as a social system characterized by wholeness, transformation, self-regulation, circularity, feedback loop, boundaries, morphostasis, morphogenesis, adaptation, equifinality, family cohesion and flexibility4. Family subsystems: the parent-child subsystem, the marital subsystem, the sibling subsystem. 5. Development of the family (significant developmental stages: the engaged couple, the newly married couple, the family with young children, the family with adolescents, launching children and moving on, the family in later life) 6. Interfamilial communication (content and relationship aspects, family\\\'s pattern of communication, nonverbal communication, empathy and understanding, problem-solving ability)7. Healthy family systems 8. Assessments used in case studies-The-Draw-a-Family Test in its version by M. Braun-Gałkowska-Family Adaptability and Cohesion Evaluation Scales (FACES III, FACES IV by Olson and others)-family maps
