"Central European Exchange Program for University Studies" (CEEPUS) promotes academic cooperation of university networks in Central and Eastern Europe and focuses on distributing scholarships for students or teachers. Available programs varies depending on scope and areas of interests of partaking institutions.

# Ethics and Politics in the European Context program connects following universities and institutes:

## University of Vienna – Department of Social Ethic

The Department of Social Ethic was established in 1935, originally as the Department of Ethic and Christian Social Science in the Faculty of Catholic Theology. Johannes Messner was the first head of the department. In 1966, the department was transformed into the Institute, and since 1997, professor Ingeborg Gabriel has been the head of the Institute. The main research areas of the Institute include: international ethics with a focus on ethics of human rights, business ethics and ecology; social ethics in ecumenical discourse, Christian social ethics in interreligious and intercultural dialogue.

Department of Social Ethic is a part of the Faculty of Catholic Theology which was founded on the 21<sup>st</sup> of February 1384 and is the oldest theological faculty in the German-speaking world.

#### University of Vienna – Department of Political Science

The Department of Political Science was established in 1971, originally as the Department of Political Theory in the Faculty of Philosophy. Now is the part of Faculty of Social Science. It is the largest political-science teaching institute in Austria agglomerating over 5,000 students and scholars.

The main focus of the Department is the transformation of governance, statehood and democracy in different policy areas, geographical regions and political spaces.

## Charles University in Prague – Faculty of Humanities

Initially founded in 1994 as the Institute for Liberal Education of Charles University. Since 2000 operating as the Faculty of Humanities. This youngest faculty in university is combined of 24 departments, 2,400 students and 200 of academic staff. Its main research and academic focus is humanities and social and cultural anthropology. Faculty of Humanities offers various study programs in English, French, German at all levels of education and supports multidisciplinary research.

# Debrecen University of Reformed Theology – Institution for Social Ethics

The Debrecen University of Reformed Theology was founded in 1538 and is one of the centers for Protestant theology in Hungary. DRTU offers programs and performs research at 4 institutes and 19 departments altogether. About 70 full-time lecturers and about 950 students work on thematic fields regarding theology, social sciences, literature, modern languages, arts.

The role of Center for Social Ethics is to explain position of the church concerning relevant questions of public life, explication of biblical, ethical standpoints for the members of the church, and non-ecclesiastical public opinion.

# University St. Kliment Ohridski - Bitola – Faculty of Law - Kichevo

University of St Kliment Ohridski founded in 1979 is a higher education institution of great significance for the southwestern region of the Republic of Macedonia. The units of university are located in several Macedonian major cities: Bitola, Prilep, Ohrid, Veles, Kichevo and Skopje.

The Faculty of Law-Kichevo entered the structure of UKLO in the academic year 2008/2009. Students accomplish their education either in Kichevo, or in Bitola on dispersed study programs.

#### University of Bucharest – Institute of Political Science

Since its establishment in 1991 the Institute of Political Science has been the most internationally-oriented Romanian higher education institution in political and social research. The Institute offers degree programs taught and examined in foreign languages (English or French) at every level. All students are enrolled in specialized English language courses

The main areas of interest are international relations, international politics, international governmental and non-governmental organizations, European Union institutions, European Union policies, international political economy, International public law, research design and methodology for international relations, global social movements or international conflict management.

John Paul II Catholic University of Lublin, Poland – Institute of Sociology

At the Institute of Sociology this academic discipline has been taught unceasingly since 1918, although on different faculties. Institute of Sociology consists of 8 chairs and currently employs around 30 highly qualified scholars. The Institute is proud of its international ties with European universities and research institutions it has developed throughout years of cooperation via involvement in projects and grants (Germany, Czech Republic, Latvia).

Thematic fields explored at the Institute concern sociological theories, migrations, family, religion, morality, law, social ethics, culture. Based on solid methodological traditions works and publications of the Institute produce data of theoretical and empirical significance.

The Institute of Sociology is a part of the Faculty of Social Science which was established in 1980. The Faculty is composed of six institutes: Institute of Journalism and Social Communication, Institute of Economy and Management, Institute of Pedagogy, Institute of Political Sciences and International Affairs, Institute of Psychology and Institute of Sociology. Overall, there are nearly 5,000 students studying at the Faculty of Social Sciences as well as 216 various-level scientific researchers.

### University of Wroclaw – Institute of Political Science

Institute of Political Science was founded in 1969 and now is one of the leading centers of political science in Poland. Institute is undertaking advanced projects combined of both domestic and international research teams, publishing in its own Polish Political Science Review.

The main areas explored at the Institute are: international relations, political thought and theories, media and communication, political marketing and social policy. In the beginning of 1990s the experience of scholars from the Institute of Political Science morphed into renowned academic theoretical tradition known in Poland as Wroclaw Systems School.

#### Cardinal Stefan Wyszynski University – Institute of Political Science

The Institute of Political Science of Cardinal Stefan Wyszynski University (UKSW) was established in the year 1999 and educates more than 1,300 students. It is recognized in Poland and abroad, particularly through research on the cultural basis of politics, relations at the interface of politics-religion, as well as research on the political and cultural processes in Central and Eastern Europe.

Unlike other centers the Institute of Political Science explores so-called "soft political science" (which focus on political idea, political philosophy, axiology of politics, and political ethics). Departments and offices conduct their research in the framework of thematic seminars, as well as in the area of special interests of academic researchers.

# BABES BOLYAI University of Cluj-Napoca – Faculty of Orthodox Theology, Section Social Theology

The Faculty of Orthodox Theology in Cluj-Napoca is a center of theological education and training based on the Apostolic Tradition of the Eastern Church. Beginnings of the Faculty of Orthodox Theology in Cluj-Napoca go back to 1924 through the establishment of the Orthodox Theological Institute in Cluj-Napoca by Bishop Nicolae Ivan.

Today, the Faculty offers various specializations and areas of study: Pastoral Theology, Didactic Theology, Social Work Theology, Hermeneutics and Doctrine, Bioethics, Pastoral Counselling and Assistance, Orthodox Spirituality, Biblical archaeology, History of Romanian Orthodox Church, Missiology and Ecumenism, Church History, Bible study and exegesis of the New Testament, Christian Morality.

Trnava University is one of the oldest universities in Slovakia. It was established by Cardinal Peter Pázmaň in 1635.

Faculty of Philosophy and Arts is one of the constituent members of the contemporary Trnava University. Its historical continuity and academic identity with the original Trnava University (1635-1777) belong to its most significant attributes. The basic mission of the Faculty which nowadays comprises 10 departments and 3 specialized working units is a Christian-oriented university education in humanities, philosophical and social sciences as well as art history.

The Faculty of Theology, with its seat in Košice, Slovakia, was established on 1 of July 2003 and provides lectures and workshops for 1400 students acquiring knowledge on academic subject of social work, family studies and Catholic theology.

# University of Belgrade – Faculty of Philosophy - Department of History

The Faculty of Philosophy is the oldest Faculty at the University of Belgrade in Serbia. The beginnings of the Faculty of Philosophy date back to year 1838 when the Lyceum School was established in the city of Kragujevac.In the same year Lectures in General History were first introduced.

Today, the Department of History consists of 36 faculty stuff members and enrolls about 450 students. Areas of learning and research are: 1) History of Ancient Greece and Near East, 2) History of Ancient Rome, 3) Medieval History, 4) Medieval History of Serbs, Serbian Church - Slavonic Language and Historical Geography, 5) Byzantology, 6) Modern History, 7) Modern History of Serbs, 8) History of Yugoslavia, and 9) Contemporary History.

#### The Catholic University of Croatia

The Catholic University of Croatia is one of the youngest Croatian universities- it was established on June 3<sup>rd</sup>, 2006. It is a private pontifical university of the Catholic Church located in Zagreb. In July 2014 the university received accreditation to conduct research activities in the field of humanities and social sciences.

CUC accepts 40 full-time students per study program annually and agglomerates around 500 students. The academic community consists of 5 departments: psychology, sociology, nursing, history, communication sciences.

The Pontifical University of John Paul II in Krakow, Faculty of Philosophy

The history of the Pontifical University of John Paul II began simultaneously with the history of the oldest Polish university - the Jagiellonian University founded on the 12nd May in 1364. In 1397 Pope Boniface IX issued a papal bull which established the Faculty of Theology. In 1954 the faculty was removed from the Jagiellonian University by the communist authorities. Between 1959-1981 the Faculty functioned independently. In 1981 John Paul II established The Pontifical Academy of Theology. Nowadays the Pontifical University of John Paul II in Krakow realizes its educational/academic activities within 5 faculties in Krakow: Faculty of Theology, F. of Philosophy, F. of History and Cultural Heritage, F. of Social Science, F. of Canon Law. http://www.pat.krakow.pl/
