(July-October 2015). Since the early 1980s I have organized an annual *Days of Human Rights* conference (2016 - XXXIV Days). I was the member of the Minister of Foreign Affairs' Advisory Board on Human Rights (2001-2002) and of the European Commission against Racism and Intolerance (2007-2012).
